**Subject: WORKSHOP ON MASSIVE OPEN ONLINE COURSE (MOOC) ON PUBLIC PROCUREMENT, SPP RULES, 2010 AND PROCUREMENT PERFORMANCE MANAGEMENT SYSTEM (PPMS)**

Government of Sindh vide circular No. SO(C-IV)/SGA&CD/4-13/16 dated 20<sup>th</sup> April, 2018 have decided that all the Procuring Agencies shall carry out procurement through officers / officials possessing mandatory certified training of procurement to be conducted through Sindh Public Procurement Regulatory Authority (Copy enclosed).

2. For this purpose the SPPRA has designed a **Massive Open Online Course (MOOC)** on public procurement and is scheduled a two day capacity building workshop for the said online course on **25<sup>th</sup> & 26<sup>th</sup> October, 2018 in Dawood University of Engineering & Technology, Karachi.**

3. The workshop aims at familiarizing the participants with important concepts of public procurement and provisions of Sindh Public Procurement Act, 2009 & Rules, 2010. Besides, a complete session on newly introduced Procurement Performance Management System (PPMS) will also be held during the workshop to introduce the new system and to educate the participant as to how NITs and other related documents will be uploaded / hosted on new PPMS-SPPRA website by the procuring agencies themselves.

It is, therefore requested that all procuring agencies under your administrative control may kindly be directed to nominate the officers / officials for the workshop who are members of Procurement Committee(s) / Consultant Selection Committee(s) / Complaint Redressal Committee (CRC)/ TFEC and mainly engaged in Procurement activities to take advantage of this opportunity for efficient and transparent procurement in your department.

5. Limited seats are available and registration will be made on first come first serve basis as the course will be conducted through individual computer. Government of Sindh have decided that all the Procuring Agencies shall carry out procurements through officers/officials possessing mandatory certified training of procurement to be conducted through Sindh Public Procurement Regulatory Authority.

The training schedule shall be circulated by the SPPRA in due course of time. All the Procuring Agencies shall enroll officers/officials involved in procurements for the said mandatory training. The Procuring Agencies under the Government of Sindh shall reconstitute Procurement Committees/Consultant Selection Committees comprising only certified/trained officers/officials. This shall take effect from 1<sup>st</sup> November, 2017.
