New Qurban Ali Abro Government Contractor Larkana presented an application to the Managing Director enclosing the copies of application dated 20-02-2018 and appeal dated 02-11-2016. The Appellant stated in his appeal that he was a good reputed government contractor having PEC license No. 49314 (C-6). Executive Engineer, Provincial Highway Division, Larkana Mr. Zaffar Ali Khokar issued an illegal order No. TC/G-55/1438 Dated 07-10-2016 where by declaring him Black Listed. The said order was illegal and unlawful hence requested for cancellation / setting aside the impugned order.


2. Accordingly notices were issued to the parties for appearing before the Review Committee and the matter was fixed on 16-04-2018 for hearing . Only the appellant M/s New Qurban Ali Abro appeared before the Committee. No body appeared on behalf of Executive Engineer, Provincial Highway Division Larkana office before the Committee. The matter was heard ex-party.

3. The contractor M/s New Qurban Ali Abro narrated the facts of matter that neither he was heard nor show cause notice was issued to him in matter of declaring him Black Listed.He had never been awarded any work by Executive Engineer Provincial Highway Division larkana. He had never participated in any procurement activity, to be carried by Executive Engineer Provincial Highway Division Larkana. The said order was issued on malafide intention just to restrain him from participating in procurement activities.

## Decision

4. After hearing the appellant and perusing the record alongwith the website of the Authority the Review Committee is of the opinion that the Procuring Agency has failed to defend its version though notice was properly issued and served to them. Their absence speaks that they have no cogent reasons to declare the contractor black listed. The order itself shows that no due course of law was adopted and there are no evidences of involvement in corrupt and fraudulent practices. The order of procuring agency is hereby set-aside and the contractor is declared as eligible to participate in all procurement activities.


