SUBJECT: BLACK LISTING OF M/S. MEHRAN ASSOCIATES ON ACCOUNT OF SUPPLY OF FAULTY / UNDER PRICE EQUIPMENT.

Sir,

I am directed to refer to the subject noted above and state that M/s. Mehran Associates (Representative Mr. Mansab Ali) office No. 87, Ali Dina Ali Mohammad, Road KMC East, Karachi, were selected for supply of office equipment including Laptops etc. on being declared successful bidder. Consequently the contract was signed for supply of Sony Vaio (ten) Lap-tops as per his offer / bid for which, the firm had quoted the lowest rate of Rs. 110,000/-. But M/s. Mehran Associates supplied the equipment, instead of Sony Vaio, they delivered Dell Inspiron 5110 which according to market prevailing price was to cost Rs.92,800/-. The lowest price for Dell Laptop was quoted by Khalid Enterprises at Rs.92,800/-. Thus, there was a difference of Rs. 17,200/- and the total loss sustained by the Government on the said consignment was Rs. 172,000/-. Also the machines were without licensed software of windows and Antivirus which would additionally cost another Rs. 95,000/-. The total loss to Government of Sindh comes to Rs. 267,000/-. After forfeiture amount of contractor's earnest money Rs. 155,000/- the net loss to Government is Rs. 112,000/-.

2. Efforts had been made to get the above equipment changed from the contractor but he was not willing to do so and also had changed his office address and the last correspondence with him, vide letter NO. SO(G)(P&D)1(01)/2012 dated 03rd September, 2012, came back without delivery due to change of address. The firm, therefore, has been black listed by the Competent Authority as per Rule 30 of SPPRA Rules 2010.

3. I am therefore, directed to request you for hoisting the above information on SPPRA website so that other government departments may become aware of the non compliant attitude of the firm towards contractual obligations.

NOTIFICATION

WHEREAS M/s. Mehran Associates having N.I.T. No.2125027-8 and Sales Tax Registration No.17-50-9805-192-37 (Representative Mr. Mansib Ali) had participated in the tender floated by this department in the month of May 2012 for supply of office equipment including Sony Vaio Lap-tops.

AND WHEREAS M/s. Mehran Associates had quoted the price of Rs.110,000/- for supply of Sony Vaio Lap-top which was the lowest price for the said equipment.

AND WHEREAS M/s. Mehran Associates had signed the contractual agreement on 24th June 2012 for supply of Sony Vaio Lap-tops at a price of Rs.110,000/-. But instead of supplying Sony Vaio Lap-Top, M/s. Mehran Associates had supplied Dell Inspiron Lap-Tops which according to market price, cost Rs.92,800/-.

NOW, THEREFORE, on the recommendation of Departmental Purchase Committee, in the meeting held on 25th September 2010 and in exercise of powers under rule 30 of SPPRA Rules, 2010 M/s. Mehran Associates having N.I.T. No.2125027-8 and Sales Tax Registration No. 17-50-9805-192-37 (Representative Mr. Mansib Ali) are hereby disqualified / blacklisted as a supplier, consultant or contractor, on being involved in the fraudulent practice of violating its contractual obligations with this Department.
