Subject:- **BLACKLISTING.**

In continuation of this office letter No. G-230/AB/1630-39/BTBB dated 25/09/2017 on the subject "**Blacklisting Notice**".

According to the decision of the Hon'able High Court of Balochistan C.P No. 724/2017 and in the light of regulations framed by BPPRA, this office issued the Blacklisting Notice to the M/S. Kitabistan Book Gallery Defence, Lahore on the following grounds (B. Grounds for Blacklisting):-

- Conviction of Fraud, forgery, (Provision of unsigned/unstamped fake Bank Certificate, Provision of fake General Books, furnished information that was false and materially inaccurate).
- Indulgence in fraudulent practices (Submission of Performance Guarantee instead of Bank Guarantee / Pay Order).

As per above mentioned regulations D, Sub-para No. ii(a), page No.3 , the submission of written reply with documentary evidence to this office with a request of hearing was fixed Five (05) working days from the receipt of this office notice, which was sent to the firm on the Email address provided by the said firm on 26/09/2017 and also sent a hard copy of the said notice to the said firm through TCS vide receipt No. 6603951866 on 26/09/2017 along with regulations and received by the said firm on 28/09/2017 at 12:25 p.m by Mr. Rafaqat as per courier service record.

After receiving the Blacklisting Notice, the said firm replied with his letter No. Nil dated 29/09/2017 has requested this office to provide the copy of regulations of BPPRA, which is just a lame excuse and delay tactics to prolong the case. Even though it is not the responsibility of this office to provide the copy of regulations framed by BPPRA, but this office has already sent the regulations along with the earlier letter and again sent the said regulations through Email on the same address on 28/09/2017 and also sent a hard copy of the regulations to the said firm on 28/09/2017 through TCS vide receipt No. 6561212218, which was received by Mr. Shahzad on 29/09/2017 at 9:30 a.m as per courier service record.

It is stated that the said firm has been failed to submit its written reply with documentary evidence to this office with a request of hearing within (05) five working days from the receipt of written notice. Therefore, it is recommended that the said firm may be blacklisted for (03) Three years as per BPPRA regulations.


