Dear Reader,

M/s Wakeel Enterprises was awarded the work on date 06-05-2016 for the construction of computer system engineering department, however it was observed very poor quality work and many discrepancies in quantities was recorded in measurement book and the contactor was informed accordingly and he was stopped the work from last 16 to 18 months. As per the multiple warning letters and reminders was sent to M/s Wakeel Enterprises (copy attached for ready references) regarding the completion of work, but M/s Wakeel Enterprises was dragging the issue from 16thJan 2018 till date, however In the last meeting at vice chancellor secretaries again M/s Wakeel Enterprises was denied to work with the agreed conditions and again they have changed their statement, so already we send notices to M/s Wakeel Enterprises several time but except piece of paper we didn't get the proper response from contractor side and he was using the abusive and derogatory language in letters even though he was tying to make spy calls from different sources to create the pressure. However due to their non professional and arrogant attitude the work is in pending from last 18 months and the future of students is on stake and for this M/s Wakeel Enterprises are fully responsible.

As per the contract agreement for the construction of Computer system Building we have identified non-conformance and unsatisfactory performance of M/s Wakeel Enterprises Company in the different aspects which was highlighted in our pervious letters which are self explanatory (The copy attached for ready reference). In over last meeting at Vice Chancellor Secretariat he was given chance to complete the task as per agreed terms and conditions but he was denied to work.

Due to unsatisfactory performance M/s Wakeel Enterprises have breach the conditions of the contract therefore M/s Wakeel Enterprises is blacklisted and security deposited shall be forfeited at our university for not taking the specified remedial actions within a specified time period which was given to them in several times, the procuring agency QUEST Nawabshah has been decided to complete the building work from the security deposit and the information regarding the black list of company M/s. Wakeel Enterprises shall be publicize and communicate the decision to the Authority and other Government departments, and also hoist on its own website.

Once again you are reminded that bring your engineers at site for entire measurements of quantities of the building work, due to your negligence and non professional attitude the future of said department's students is on stake and your company is fully responsible for delay in completion of work and the same is already forwarded to the concerned departments for information and record. This is final reminder to your office bring your engineers with 7 days and complete the work as well as make entire measurement with the university engineering team incase of failure your security will be forfeited and your company will be blacklisted and same information will be forwarded to concerned department.

Once again, you are informed to come forward and resolve the issue at earliest and finalize the work, your response within one week will be highly appreciated in case of failure the SPPRA, PEC & other related rules will be applied and your company will be announced as blacklisted and the same will be forwarded to concern departments for their information.
