Back Ground:- Executive Engineer Machinery maintenance Division (Hyd) Digri @ Kotdiji invited NIT vide No:TC/G-55/154 Dated: 27-02-2019, The proprietor of M/s Wazir Ali Panhyar & Sons applied for work placed at Serial No:32 of NIT i.e. (Construction of road from Lakha Kandiyari (Kandiyari road) to village Zanwar Khair Muhammad Lashari via Haji Allah Wadhayo Bhanbhan road mile 6/0-7/4. But he could not put / drop the tender documents into the tendering box. Accordingly to complainant, the procurements committee has violated the SPPRA rules by keeping me out from competitive bidding process.


