That the above contractors submitting relevant documents before CRC Committee about his grievances / complaint made against tendering process, the Complaint redressal committee (CRC) thoroughly reviewed the complaint along with relevant papers of complainant in the meeting after scrutiny / Examination of the record it has been observed that **M/s Asif Raza** submitted tender documents which download from SPPRA website along with D.R / Tender Fee Rs. 2000/- and Call Deposit Rs.75000/- for the work of Scheme No: 20 Repair and Maintenance of Office Building Municipal Committee Shahdadpur which tender cost is 2.00 Million, whereas the required amount of Call deposit of that work is 100,000/- the complainer not accompanied / provided bid security of require amount due to tender process was not accepted.

That **M/s Sufi Enterprises** submitted tender documents which download from SPPRA website along with D.R / Tender Fee Rs. 1500/- and Call Deposit Rs.50, 000/- for the work of Scheme No: 08 Construction of C.C Block and paving flooring at ward No.08 Municipal Committee Shahdadpur which tender cost is 1.00 Million, whereas the required amount of DR / Tender Fee of that work is 2,000/- the complainer not accompanied / provided bid security of require amount due to tender process was not accepted.

That with regard to contents of the complaint, it is submitted that complaint made by **M/s Asif Raza & M/s Sufi Enterprises Govt. Contractor** is false and baseless. It is further submitted that complainant has not deposited require call deposit and D.R / Tender fee and the said contractor failed to submit such documentary proof before date of tender process.

That the contents of the complaints are vehemently denied, it is submitted that Tenders were only opened on 30-06-2020 @ 2:00 PM, and process was completed on same date, and time.

That with regard to contents of the complaint it is submitted that no any mis-appropriation and illegal act has been committed, no any favoritism and sympathy was given to any contractor.




Decision:-


