

MINUTES OF MEETING REGARDING CRC HELD ON SCHEDULED DATE TIME & VENUE ON 09-09-2020 IN THE OFFICE OF CIVIL SURGEON CIVIL HOSPITAL DADU ON THE COMPLAINT OF AGGRESSIVE BIDDER (M/S AMMAR & MAAZ TRADERS HYDERABAD). THE BIDDER M/S AMMAR & MAAZ TRADERS HYDERABAD ATTENDED OFFICE BEFORE SCHEDULED TIME AND PLACE.

PROCEEDINGS OF MEETING:-

- The meeting started with the permission of chair i.e District Health Officer Dadu Chairman CRC.
- All the members and bidders well come for attending the scheduled meeting and introduced one by one alongwith members CRC committee.
- The Chairman CRC offered to the owner of M/s Ammar & Maaz Traders Hyderabad to address the grievances as stated in the complaint made by him point by point within the SPPRA Rules.
- M/s Ammar & Maaz produced his complaint and briefed regarding the matter as stated in his application.
- The Chairman CRC replied to the bidder with proof on which he was not awarded the item.
- The Chairman CRC also produced to bidder all the samples of item which he have quoted and the complaint made of item at sr. No: 154 instead of 164 which he have quoted.
- More over the Chairman CRC and members verified to bidder the SPPRA Rule quoted in the application "72-2(c) "is not justified/ pertains for item as quoted by the bidder and also against the matter stated in the application/complaint.
- The Chairman CRC and members also produced the samples quoted by the competitor bidders and verified personally.
- The bidder also verified the samples which he have quoted "Dialyzer with tubing set of Fresenius Medical Care Germany) but the tubing set which were found another company of Vital Healthcare SDN.BHD and found differed as required in the Evaluation to PA, the other side Dialyzer with tubing set were found NIPRO quoted by bidder M/s Lab Link Enterprises Hyderabad and declared best evaluated, Hence the PA rejected the item quoted by M/s AMMAR & MAAZ traders Hyderabad due to the reasons stated.
- After all verifications by the bidder, committee unanimously satisfied from the documentary evidences and proof on which Ms/ Ammar & Maaz rejected the PA.
- The Chairman CRC and members requested to PA to proceed further under SPPRA Rules within stipulated time and inform to the concerned bidders accordingly.
- The meeting ended with the vote of thanks to the chair.
