

FACT FINDING REPORT OF COMPLAINT REDRESSAL COMMITTEE

An application by Mr. Ali Nawaz Alias Hakim Ali Abro, Government Contractor (here referred as complainant) (copy attached at Annexure-A) was received on 30-05-2019 against the tenders invited by the Executive Engineer, Buildings Division, Larkano. Meeting of Complaint Redressal Committee (CRC) was previously scheduled to be held on 03-06-2019 @ 12.00 (noon) but due to official engagements of Mr. Ahsan Ali Shah, Executive Engineer, Public Health Engineering Division, Larkano/ Member at Headquarters therefore; the Meeting was postponed and rescheduled after the Eid-ul-Fitr Holidays on today i-e 12-06-2019 @ 12.00 (noon) in the office of the Superintending Engineer, Works & Services Department Larkano as per SPPRA Rule-31.

Background:- Executive Engineer, Buildings Division, Larkano invited tenders for different works vide this office NIT No.TC/EE/302, dated 17-04-2019 with date of opening was 09-05-2019 @ 02.00 p.m including the work at Sr. No.02 approved under the title of work viz: "Construction of veterinary Dispensary 02 Nos. at Bero Chandio and Mahota, Taluka Larkano (Construction of Veterinary Dispensary at village Mitho Khuhro, UC Aghani, Taluka Larkano) as per location changed by the Competent Authority vide letter No. DC/AD/DEV/2019/119, Larkano dated 02-01-2019 wherein Thirteen (13) No. of contractors / bidders were participated as mentioned below:-


- 1) Mr. Mashooque Ali Bhutto.
- 2) Ali Nawaz Alias Hakim Ali Abro.
- 3) M/S Bukhari & Sons.
- 4) M/S Al-Mustafa & Co.
- 5) M/S Mehran Builders.
- 6) M/S Asif Ali Kalhoro.
- 7) M/S Imtiaz Ali & Co.
- 8) M/S Waqar Enterprises.
- 9) M/S Naveed Jatoi & Co.
- 10) M/S Darban Ali Khero.
- 11) Mr. Ali Hassan Junejo.
- 12) Mr. Pyar Ali Solangi.
- 13) M/S Ali Nawaz Mirjat.


Mr. Ali Nawaz Alias Hakim Ali Abro complained about the unfairness of the bidding process was made by the Procurement Committee and demanded for cancellation of all tenders including the work at Sr. No. 2 namely "Construction of veterinary Dispensary 02 Nos. at Bero Chandio and Mahota, Taluka Larkano" (Construction of Veterinary Dispensary at village Mitho Khuhro, UC Aghani, Taluka Larkano) under NIT No.TC/EE/302, dated 17-04-2019 by the Chairman, Procurement Committee / Executive Engineer, Buildings Division, Larkano vide Corrigendum No.TC/EE/424 of 2019, dated 10-05-2019.


The Executive Engineer, Buildings Division, Larkano / Chairman Procurement Committee stated in his statement that the bidding process of the NIT was made transparent in absolute manner as specified in the SPPRA Rules wherein (Thirteen) 13 No. of Contractors / Bidders participated in the NIT amongst them (03) Contractors / Bidders qualified and rest of the Contractors / Bidders put their blank tenders in the box, resulting that disqualified. However, the rates quoted by Mr. Mashooque Ali Bhutto, Government Contractors was found 1st lowest and reasonable, the rates quoted by Mr. Ali Nawaz Alias Hakim Ali Abro was found 2nd lowest and highest as well as rates quoted by M/S Mehran Builders found 3rd lowest and highest respectively hence, rejected among other bidders (copy attached at Annexure-B).

However, it is pertinent to mention here that plot of the Unit namely "Construction of Veterinary Dispensary at village Mitho Khuhro, UC Aghani, Taluka Larkano" approved by the competent authority was not suitable, therefore; the tender for the work in question stands cancelled by the Executive Engineer, Buildings Division, Larkano / Chairman Procurement Committee vide Corrigendum No. No.TC/EE/424 of 2019, dated 10-05-2019 until and unless a new suitable plot is received from the competent authority (copy attached at Annexure-C).

Conclusion:- Since, the tender for the work namely "Construction of Veterinary Dispensary at village Mitho Khuhro, UC Aghani, Taluka Larkano" wherein Mr. Ali Nawaz Alias Hakim Ali Abro participated and found 2nd lowest has been cancelled by the Executive Engineer, Buildings Division, Larkano / Chairman Procurement Committee, therefore; allegations in the complaint made by Mr. Ali Nawaz Alias Hakim Ali Abro regarding unfairness in the bidding process does not arises at this stage as well as demand for cancellation of all other tenders are not justified as he has not participated in rest of tenders against which he wants to cancel therefore; instant complaint is unjustified and does not carry the weight-age hence, filed.
