As the meeting was scheduled to redress the grievances of M/S. Al-Fateh Construction Company, (2) M/S Muzafar Hussain Construction Company and (3) M/S Ibrahim Solangi Construction Company in connection of complaints regarding N.I.T No:XEN(Edu:Works)/TC/1314, dated 03-09-2020 against the Executive Engineer, Education Works Division Jamshoro.

Accordingly the Chairman, Complaint Redressal Committee / Superintending Engineer, Education Works Circle Hyderabad-I along with Complaint Redressal Committee members heard the aggrieved party/ the only representative of all these 03 complainants, who told that I had been attended the office of Executive Engineer, Education Works Division Jamshoro on dated 25-09-2020 which was the receiving as well as opening date of tenders / Bids called vide N.I.T No:XEN(Edu:Works)/TC/1314, dated 03-09-2020 but no any concerned officer/official was present there between 1.00 p.m to 1.30 p.m and he left the office with the reason that receiving time was 1.00 p.m as per schedule.

Later on Chairman offered the comments of Procurement Committee side. The Chairman Procurement Committee/Executive Engineer, Education Works Division Jamshoro informed before the forum that I was present in the office from 11.00 a.m to the end of the bidding process upto 5.00 p.m. He further clarified that the receiving time was extended from **1.00 p.m to 2.00 p.m** due to Jumma prayer, at 3.00 p.m after Jumma prayer and the opening time was extended from **2.00 p.m to 3.00 p.m**. (Such Notice was affixed

on the office Notice Board) (copy attached). The box was opened in presence of all the members of Procurement Committee as well as bidders/their representatives, who participated in the process and no one objected at that time, all the tenders were opened and announced loudly as per SPPRA Rule No:41 (the attendance sheet and photographs of dropping the tenders in the box as well as reading of bids also available and these are presented before the Redressal Committee).

The Procurement Committee Chairman also informed that all the process was done in accordance with SPPRA Rules transparently, fairly and no any violation of Rule-24 was made as alleged by the complainants / aggrieved party.

Review: - The Committee reviewed the submitted complains of Contractors and after listening to the both parties, is of the unanimous view that no any mis-procurement has been done and tender process of said N.I.T was made fair and in transparent manner and no any violation of Rule 24 has been made

Decision: - The Committee unanimously rejected the application of the complainants M/S. Al-Fateh Construction Company, (2) M/S Muzafar Hussain Construction Company and (3) M/S Ibrahim Solangi Construction Company.





It is therefore requested that above namely Contractors complaint is baseless.




