This is in reference to your complain vide Letter Ref: NIL dated: 08-10-2020 received in this office on 12-10-2020, **Attached as Flag - A.**

The matter was placed before the Complaint Redressal Committee, of KW&SB, and it was found that you participated in the tender as captioned above, which was opened on 9-7-2020 in which you quoted a rate of **38% below** the estimated cost.

The Evaluation by the Procurement Committee was checked. It may please be noted that the subject tender includes an item of Cartage, amounting to Rs. 42,66,483/= , in addition to the BOQ Quantities costing of Rs. 5,46,30,029/= based on Composite Schedule Rate 2012.


The working of the Evaluation Committee, is based on SPPRA Rules and Regulations, 11.3.3 which provides a complete and comprehensive table to cater for Cartage. After application of SPPRA Regulation 11.3.3 the submitted bid was evaluated to be **42.491 % below** the Estimated Price and this detail Calculation as provided by the SPPRA Regulations was checked by the CRC. **Attached at Flag - B.**

Since SPPRA Notification /Regulation 11.3.4 issued vide No DD(A&F)/SPPRA/17-18/22 dated 5-7-2017 **Attached at Flag - C**, provides that: "In case a procuring agency receives a bid, which is more than 30% **below the Engineer's Estimate or Composite Schedule Rates (CSR)**, the procuring agency can reject that particular bid(s)..."


On account of above CRC uphold the decision of procurement committee and therefore your appeal is dismissed / disposed-off.


