**MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE (CRC) MEETING HELD ON
27-11-2020 TO HEAR THE COMPLAINT FOR TENDER PROCESS OF SMALL DAMS DIVISION
KOHISTAN-I DADU & SMALL DAMS DIVISION KOHISTAN-II JAMSHORO**

The CRC meeting of Small Dams Organization held on dated 27th November, 2020 at Chief Engineer/ Project Director Small Dams Office Hyderabad and presided over by Mr. Zahid Hussain Shaikh Chief Engineer/ Project Director Small Dams Organization as Chairman CRC alongwith Members of CRC.

Complaint Regarding NIT No.XEN/SDO/K-I/TC/587 Dated 28-09-2020

1. After going through the complaint made by M/s. Muhammad Iqbal Shaikh & Co Hyderabad regarding disqualifying his firm in the Tender process and after perusal of relevant documents produced by the concerned Executive Engineer Small Dams Division Kohistan-I Dadu, it was found that M/S Muhammad Iqbal Shaikh & Co Hyderabad does not fulfill requirement of specific experience, but in other specified factors i-e (c) Personal Capability (d) Equipment Capability, (e) Financial soundness/ status the marks awarded by the procuring committee were 53% which were rectified as 67%, inspite of rectifying, M/S Muhammad Iqbal Shaikh & Co Hyderabad could not secure qualifying score i-e 70%. Hence the firm stands disqualified.
2. After going through the complaint of second complaining firm i.e M/s Bahadur Ali Shaikh Government Contractor of Mr. Bahadur Ali Shaikh it was found that marks awarded by the procuring committee are correct and Mr. Bahadur Ali Shaikh of M/s Bahadur Ali Shaikh Government Contractor firm admitted with the decision and withdrew his financial Bid

Complaint Regarding NIT No.XEN/SDO/K-II/TC/334 Dated 28-09-2020

3. After going through the complaint made by M/s. Muhammad Iqbal Shaikh & Co Hyderabad regarding disqualifying his firm in the Tender process and after perusal of relevant documents produced by the concerned Executive Engineer Small Dams Division Kohistan-II Jamshoro, it was found that M/S Muhammad Iqbal Shaikh & Co Hyderabad does not fulfill requirement of




