Meeting of Complaint Redressal Committee (CRC) was held on 16-09-2019 at 02:30 p.m in the office of the Superintending Engineer, Provincial Highways Circle Larkano in accordance with the SPPRA Rule 31(4) & (5) of Sindh Public Procurement Rules-2010 (Amended 2017) to contemplate into complaints concerning for having not issuance of blank tender documents made by following contractors v/s Executive Engineer, Machinery Maintenance Division Khairpur at Shikarpur against the above subjected NIT.

Accordingly all (19) No. of above complainants as well as Executive Engineer concerned / procuring agency have been issued letter vide No. SE(PHWC)BB/1652 dated:-11-09-2019 to attend the meeting of Complaint Redressal Committee on dated 16-09-2019 to ascertain the matter.

Out of (19) No. of complainants only 02 No. of complainant appearing at Sr. (15) M/s M.M. Contractors and at Sr. No.19 M/s Din Muhammad Enterprises Builders Government Contractor attended the CRC Meeting wherein M/s M.M Contractor withdrew his complaint which was presented before the Committee (Copy of withdrawal application is attached).

However, M/s Din Muhammad Enterprises Builders Government Contractor informed the Committee that he has applied for issuance of (02) No. of works invited by the Executive Engineer / Procuring Agency @ Sr. No.4 & 5 accordingly Committee asked to produce / submit the Call Deposits and pay orders for the applied works but M/s Din Muhammad Enterprises Builders Government Contractor shown only 01 No. Call Deposit for the work at S.No.05 instead of 02 Nos nor he produced the Pay order / D.R copy for the works against he applied before the Committee subsequently he has been asked to produce the such paid-up copy of Challan for renewal of PEC for the year 2019-20, but he also failed to provide the same.

Accordingly, Mr. Iqbal Ahmed Pathan, Executive Engineer Machinery Maintenance Division Khairpur @ Shikarpur/ Chairman Procuring Agency informed the Committee that 14 No. of complainants @ S.No. 01 to 14, withdrawn the complaints on their letter-heads which was produced before the Committee, subsequently rest of the complainant M/S Din Muhammad Enterprises Builders, Government Contractor was not entertained to participate in the tendering process as he dispatched simple application for (02) No. of works at Sr. No.4 & 5 while attached a photo copy of the Call Deposit which is contrary to the requirement of participation in the tendering process.

Conclusion:- In light of the above discussed matter, Committee decided to file the instant complaints which does not carry the weight-age in this regard.
