

A meeting of the Complaint Redressal Committee (CRC) was held on **12<sup>th</sup> September, 2019** at **11:30 a.m.**, under the chairmanship of the Director General Excise & Taxation Sindh, / Chairman, Redressal Committee at 3<sup>rd</sup> Floor, "Karachi House", adjacent Muhammadi House, I.I. Chunderigar Road, Karachi.

Following members of the Committee attended the meeting and Mr. Whaeed Shaikh, Deputy Director (Admn), Motor Registration Wing, Karachi represent the Procurement Committee.

The meeting started with the recitation from Holy Quran. The Chair welcomed the participants and informed the Committee that the CRC was constituted by the Secretary Excise, Taxation & Narcotics Control Department, vide Notification No.SO(B&A)ET&NC/Number Plates/2018-19/76, dated 08<sup>th</sup> January, 2019 to address the grievances if any, regarding procurement of the items specified in the subject Committee.

Mian Abdul Jabbar, CEO M/s. Pakistan Business International Karachi, the complainant stated that his request is the same that to consider the possibility of re tendering or consider his bid in the public interest as only single bid was received and he was few minutes late due to heavy rain in the city, so a fair competition could not be held.

The meeting started with the recitation from Holy Quran. The Chair welcomed the participants, the Deputy Director (Admn), Motor Registration Wing, Karachi, briefed the committee that Mian Abdul Jabbar of M/s. Pakistan Business International reached approximately 30 minutes late to participate in bidding process of procurement of Number Plates, therefore, the committee did not allowed him to participate in the bidding process on the objection of CEO of M/s. Progressive Engineering Association one of the participant / bidder. He has also produced minutes of meeting bearing No.DVR/MR(43)/Procurement/NP-TTS-U/2019-20/1491, dated 06<sup>th</sup> September, 2019 in this regard.

The Committee thoroughly examined the record and consult the SPPRA Rules 2010, Rule 24(1) of SPPRA Rules 2010 (amended 2019) clearly define the process of submission of bid, which is reproduced as under:

*"Bids shall be submitted on the place, date and time and in the manner specified in the tender notice and bidding documents and any bid submitted late due to any reason whatsoever, shall not be considered by the procurement committee".*


