**SUBJECT: MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE MEETING FOR THE PROCUREMENT OF MEDICAL & LABORATORY EQUIPMENT.**

With reference to letter received from M/s Global Marketing System captioned at 'D', the meeting of Complaint Redressal Committee was called by M/s Global Marketing System, in light of SPPRA Rule-31. The meeting was held under Chairmanship of Worthy Vice Chancellor (Chairman, Complain Redressal Committee) on September 12<sup>th</sup> 2019 at 01:00 pm in the committee room of Vice Chancellor's Secretariat. The following attended the meeting in addition to CRC, to properly redress the grievances of the vendor:

The meeting was started with recitation of few verses from the Holy Quran by Prof. Dr. Muhammad Saleh Khasekheli. Accordingly, the Chairman welcomed the committee members and the bidders. Then after as per agenda, the Chair invited Mr. Syed Muhammad Irfan-ul-Haq from M/s Global Marketing Systems to express his view point. He narrated following points which are summarized as under:

1. The Company had submitted its bid via single stage-two envelop (Technical & Financial Proposal).
2. The technical proposal was qualified however the financial proposal was rejected because the bid was quoted in two currencies. The same was written as "Conditional Bid" in comparative statement and interestingly the term 'Conditional' is un-defined in SPPRA Rules.
3. The company, M/s Global Marketing System, has vast business experience in the supply of similar kind of products to wide range of national and multi-national companies, they always submitted their bid in same pattern for the liberty of Procuring Agency.
4. Moreover, the two currencies were given with respect to condition given in bid document. In last, Mr. S. M. Irfan-ul-haq thanked the committee for giving chance to hear and hope for fair decision.

Then, the Committee had given the chance to procurement department to respond against the grievances, which are narrated below:


1. The Purchase Officer informed the CRC Committee that total thirteen bids were sold, out of which twelve firms had submitted their bids, all firms were technically qualified and their financial bids were opened on 13-07-2019. It was observed that M/s Global Marketing System, Khi


- (The Complainant Firm) and other three firms had quoted conditional bids i.e. *given prices in two currencies against each item*. The same was discussed with SPPRA Team for expert opinion. They opined that "*as per book, the bids are conditional*". Thus, the financial bids of the four firms were rejected, due to same practice.
2. The Complainant Firm also stated that they quoted rates as per clause 9 and 10 mentioned in bid document. The instructions at clause 9 & 10 of tender document were given to help bidder to quote price and currency respectively. More importantly, the Instruction 10.2 clearly stated that "Price shall be quoted in foreign currency for goods offered outside the Procuring Agency's country on C&F Basis".
  3. Hence, the action taken is completely according to procedures as laid down in SPPRA Rules & Regulations in practice at this University.


After discussion and careful listening to the vendor and procurement department, the committee concluded the meeting as follows:

1. The miscommunication was occurred because of bid document and grievance of M/s Global Marketing System is valid. Therefore, the Bid Evaluation Report is considered cancel and revised Bid Evaluation Report shall be prepared.
2. The University Central Purchase Committee was advised to re-consider financial proposals of all four rejected firms for bid evaluation i.e. M/s Global Marketing System, M/s Qualitron Corporation, Khi, M/s Qualitron Corporation, Khi (*Alternate Offer*) and M/s Scientific Technical Corporation, Lahore.
3. It is worth to mention here that the members of Complain Redressal Committee add their valuable remarks that the conversion rate shall be the same as on financial bid opening date (as mentioned in bid document) and No Escalation shall be admissible on foreign currency exchange rates. However, it is better to take rates quoted in PKR currency.

The meeting was ended with vote of thanks to the chair.
