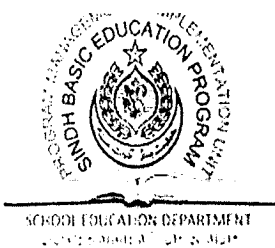



Faiz Scientific Company against non-qualifying in the tender lot No 7 & 7A for the procurement of furniture & fixture for USAID SPEB Schools (*Attendance Sheet is Attached*)


2. Meeting was attended by the complainant and Procurement Committee members (*Attendance sheet is attached*)
3. The Chair asked the complainant regarding grievances of M/s Faiz Scientific Company, Mr. Tahir requested the chair to review technical evaluation of both bids 7 and 7A,
4. Procurement Committee, briefed the CRC that the complainant did not submit mandatory information as required for a responsive bid; moreover in technical evaluation the complainant obtained 49.4 marks out of 100, where as 80 marks are required for qualification.
