



MINUTES OF COMPLAINT REDRESSAL COMMITTEE.

Complaint Redressal Committee was arranged in response to complaints against NIT No.TC/1198 dated 02-08-2019 for Works of Public Health Engg: Division No. 1, Hyderabad. The NIT was hoisted on SPPRA Website & as well as published in news papers. Complainant M/s. Atif Ali Government Contractor approached Chief Engineer PHED Hyderabad who is Chairman Complaint Redressal Committee. CRC meeting was called vide letter GM/PHED/CRC/73 dated 13-01-2020 scheduled on 16-01-2020 at 12.30 pm. On quarry from Chair, Executive Engineer Public Health Engg: Division No-I, Hyderabad intimated that an application without reference and date was received with a simple signature complaining there in violation of procurement procedure of said NIT. Engineer Public Health Engg: Division No-I, Hyderabad intimated that Bid Evaluation Report was hoisted on SPPRA website on 3rd January 2020 and as per rule after hoisting on website 03 days are to be required to be wait and thereafter work can be awarded (SPPRA Rule-45). He was of view that aggrieved bidder did not approach within permissible time frame given in rules of SPPRA, therefore his application may be rejected accordingly. During meeting it was observed that District Accounts Officer Hyderabad did not attend meeting.

After detailed deliberation it was concluded that further discussion of CRC under circumstances mentioned above will be wastage of time. Therefore complaint of M/s. Atif Ali was disposed off accordingly.

Meeting ended with vote of thanks from and to the Chair.
