A meeting of Complaint Redressal Committee for MSDP procurement of contract package WW-10 & WW-12 was held on 27th January, 2020 at 12:00 p.m. at the Committee Room of Program Management Unit, USAID Sindh Municipal Services Delivery Program, and Government of Sindh. The meeting was convened for Complaint Redressal of contract package WW-10 & WW-12, by M/s. Engineering Links International and M/s. Muhammad Iqbal Shaikh & Co. respectively.

1. Following members of the Complaint Redressal Committee attended the meeting. The attendance sheet duly signed are attached (Annexure-A).

3. The chair welcomed the Complaint Redressal Committee members and appraised the forum regarding the background of the tenders and respective complaints of bidders.

4. Since M/s. Engineering Links International had already on 15th January, 2020 taken back its Bid Security (Annexure – A) via an application hence the request sent on 21st January, 2020 the application cannot be entertained Mutatis – Mutandis read with 32(1) of SPPRA rules.

5. M/s. Muhammad Iqbal Shaikh & Co. did not provide "Integrity Pact" which was a mandatory requirement as per "Clause H" of "REVISED ELIGIBILITY & QUALIFICATION CRITERIA", attached with Pre Bid Meeting of the same tenders (Annexure B), which makes the bidder non responsive.

6. As per clause IB-11 (F) of "REVISED ELIGIBILITY & QUALIFICATION CRITERIA" the bidder mislead the procuring agency by concealing the facts, which is evident from the letter of NAB (Annexure C), that M/s. Muhammad Iqbal Shaikh & Co., was required under Section u/s 19 of NAO.1999.

7. As per the clause 5 & 6 of "Criteria for Qualification" attached at "Appendix A to Bidding Data". "No Black listing Declaration" and "Litigation History" was to be separately submitted on Rs. 100/ stamp

8. Hence it was decided by the Complaint Redressal Committee that the contractor M/s. Muhammad Iqbal Shaikh & Co. did not full fill the mandatory requirements of the bidding process and thus was rejected for the subject tender.

9. The meeting ended with a vote of thanks to and from the chair.




