The Complaint Redressal Committee (CRC) asked contractor to provide proof / evidence of his allegations levied by him against procurement committee in writing but he did not provide any single proof/evidence before Complaint Redressal Committee (CRC) therefore made following decision.

Therefore Complaint Redressal Committee (CRC) is not satisfied / agreed with allegations of contractor therefore decided that in the best interest of council and public, the SPPRA authorities are requested to set a side the complaint made by M/S Fatima & Co Works and Services because he has not provided any written proof or evidence before Complaint Redressal Committee (CRC)


