

## MINUTES OF COMPLAINT REDRESSAL COMMITTEE.

Complaint Redressal Committee was arranged in response to complaints against NIT No.TC/1295 dated 22-11-2019 for Works of Public Health Engg: Division Thatta. The NIT was hoisted on SPPRA Website & as well as published in news papers: Complainant M/s. Haji Habibullah Khan Government Contractor approached Chief Engineer PHED Hyderabad who is Chairman Complaint Redressal Committee. CRC meeting was called vide letter No. GM/PHED/CRC/61, dated 10-01-2020 scheduled on 13-01-2020 at 3.00 pm. District Accounts Officer Thatta did not attend the meeting. Aggrieved bidder M/S Haji Habibullah Khan did not attend the CRC meeting.

On quarry from chair, Mr. Sajid Hussain Mallah Concerned Executive Engineer PHE Division Thatta intimated that bidder has raised objection on single stage two envelop method. Contractor is of view that nature of work is simple and does not need to follow single stage two envelop method. On quarry from Chair, Executive Engineer PHE Division Thatta intimated that NIT containing 10 works need technical expertise, therefore SPPRA Rule 46 (2) was adopted.

After thorough discussion it was concluded that aggrieved bidder did not attend CRC meeting in light of Executive Engineer PHE Division Thatta explanation, complaint made by Haji Habibullah Khan disposed off.

Meeting ended with vote of thanks from and to the Chair.
