SUBJECT:- MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE (CRC) MEETING HELD ON 30.06.2020 TO HEAR THE COMPLAINTS/GRIEVANCES AGAINST NOTICE INVITING SEALED BIDS FROM OLD PRE QUALIFIED CONTRACTORS THROUGH NIT NO.TC/G-55/TFWSD/81 MIRPURKHAS DATED 16.06.2020 CALLED BY THE EXECUTIVE ENGINEER THAR FRESH WATER SUPPLY DIVISION MIRPURKHAS COMPLAINT AS PER VIOLATION OF RULE-31 OF SPP RULES-2010.

Reference:- This office letter No.DD/CRC/163 of 2020, dated: 02.07.2020.

In continuation to this office letter No. under reference alongwith minutes of meeting held on 30.06.2020, wherein the committee discussed the phrase "particular assignment" mentioned in SPP Rule-27 (2) SPPRA Rules-2010 (Amended 2017) regarding scope of pre-qualification.

The committee in its meeting held on 30.06.2020 decided that the above phrase refers to all the works mentioned in the PC-I and single pre-qualification is enough for that PC-I or project. Resultantly the committee upheld the Pre-Qualification previously conducted for the new works and validated the process.

However, after going through the relevant regulation No.2.14 *Aim of Pre-Qualification*, wherein, it is clearly mentioned that "*Pre-qualification is made on tender to tender basis and is valid for such project/scheme only*".

Now, after going through the relevant Regulation for procurement No.2.14, the undersigned is of this opinion that procuring agency in this particular case should go for fresh Pre-Qualification or single stage two envelope procurement process.
