**MINUTES OF THE COMPLAINT REDRESSAL COMMITTEE (CRC) MEETING  
HELD ON 16.07.2020 TO HEAR THE COMPLAINTS/GRIEVANCES AGAINST  
MR. SHARAFUDDIN BHANBHAN, EXECUTIVE ENGINEER EAST DIVISION,  
KHAIRPUR FOR UPLOADING BIDS WITHOUT ATTENDING THE OFFICE ON  
BOTH PROCUREMENT DATES.**

**Background:-**

1. Government of Sindh constituted Complaint Redressal Committee vide Notification No.SO(R&S)8-110/2018-19/254, dated 30.12.2019 in terms of Rule 31(b) of Sindh Public Procurement Rule 2010.
2. The Complaint Redressal Committee meeting was convened for hearing of grievances / complaints of above cited / mentioned bidder / complainant in connection with the NIT invited by Executive Engineer, East Divisions Khairpur vide No.TC/G-55/750 dated:05.06.2020 & Corrigendum No. TC/G-55/875 Dated: 24.06.2020.

**Proceeding / Decision:-**

After hearing the grievances of the complainants and going through the relevant letters/documents produced by Procuring Agency, Complaint Redressal Committee (CRC) observed that the said NIT No. TC/G-55/750 Dated the 05<sup>th</sup> June, 2020 & Corrigendum No.TC/G-55/875 Dated: 24.06.2020 for which the Technical Bid was opened on 29-06-2020 & the Financial Bid on 02-07-2020. Accordingly the Work Order was issued on 10-07-2020. The complainants/aggrieved bidders argued that the PA & Procurement Committee was not present in their office on the date & time of the tender dropping & opening. However, the PA provided the Bid Evaluation Report with signatures of all the members of Procurement Committee. The Complainants also shown the video of empty XENs office as an alleged proof for their claim. In this regard, the undersigned or the CRC, neither has the means nor has the access to verify the authenticity of the video clip shown as to whether it was taken on the same date & time.

Keeping in view the above, the Committee is of the unanimous opinion that the complainants/aggrieved bidders did not participated in the said tendering. Moreover, the PA has completed the proceeding of SPP Rule-50. The Committee, therefore declares the procurement process as Valid.
