

The following contractors were lodged their complaint before the SPPR Authority and received to the CRC constituted under rules 31 of SPPRA rules 2010 amended and up to date against the Procurements Committee MC Mirpur Mathelo which was opened the tenders display on the WEB site of SPPRA for the year 2019-20

The meeting was started with the approval of the Chairman of the Complaint redressed Committee Municipal Committee Mirpur Mathelo headed by the Chairman Municipal Committee, Mirpur Mathelo.



The District Accounts Officer / member of the committee (CRC) read all the complaints before the CRC and found that all complaints are almost same nature/identical that procurement committee were not present on the day of procurement on 07-07-2020 in office of the Municipal Committee Mirpur Mathelo.

The District Accounts Officer member of the committee (CRC) shown the entire record/proceeding of 07-07-2020 to the Chairman CRC and member, including attendance sheet of the participants who have succeeded to get the contract being lowest bidder as per rules,


The CRC considered entire record of 07-07-2020 and found that various contractors were participated in the procurement proceedings and the lowest bidders have succeeded to award contract. The accounts Officer/member of the CRC also produced the attendance sheet of the persons/contractors, who participated in the procurement process on 07-07-2020 which shown that that the allegation of the complainant that procurement committee are not present on 07-07-2020 is baseless and have no substance at all

One Muhammad Siddique Engineering contractor alleged in his complaint that the Engineer M.C Mirpur Mathelo was busy in the meeting of Commissioner Sukkur Division Sukkur on 07-07-2020 which is sheer lie. The Engineer was present in the office of Municipal Committee Mirpur Mathelo on 07-07-2020 and attend the proceedings of Procurement Committee being a member of the procurement committee and he did not attend the meeting in the office of the Commissioner, Sukkur Division which is evidence of the fact that the contents of the complaint are baseless

It is evident of the fact that the meeting of the procurement committee was held on 07-07-2020 and the lowest bidders were become liable to award contracts in accordance with SPPRA rules and uploaded the BER and other relevant documents on the WEB site of SPPRA.

The Proprietor of Al-Noor Enterprises / Professional contractor member of CRC informed that it is the group of black mailers those do not intend to participate in open bidding proceedings but try to black mail to get gratifications.







The Chairman Municipal Committee Mirpur Mathelo / Chairman CRC MC Mathelo agreed with the facts narrated by the members of the CRC


In the end the Chairman MC Mirpur Mathelo/Chairman CRC thanked the members of the CRC and meeting was ended,
