

**MODIFIED MINUTES OF THE MEETING OF D.D.C. SANGHAR HELD ON 18-5-2012 UNDER THE CHAIRMANSHIP OF DEPUTY COMMISSIONER/PROJECT DIRECTOR FOR DISTRICT SANGHAR.**

A meeting of District Development Committee (DDC) Sanghar was held under the Chairmanship of Deputy Commissioner Sanghar/Project Director on 18-5-2012 to re-consider the Development Schemes sponsored by Mr. Roshandin Junejo, MNA under MNA's Programme 2011-12.

The following four schemes sponsored by Mr. Roshandin Junejo MNA (NA-236) under Non-ADP allocation for development schemes proposed under MNAs Elected in Sindh were cleared/approved in the DDC meeting held on 5.4.2012 and its Administrative Approval was also issued vide No.DC/SGR/330 dated 6.4.2012 and the same were send to the Planning & Development Department Government of Sindh, Karachi, for further action.

1. Provisioning safety Bund around the village of UC Mitho Khoso Taluka Tandoadam (cost Rs.10.000 Million).

2. Improvement of road from Tableghe Markaz to Mohammadi Chowk & approach to Juman Shah road (with asphalt surface) (Cost Rs.14.986 Million).
3. Improvement of road from Latif Gate to Mohammadi Chowk including approach to Khyber road (cost Rs.15.000 million).
4. Construction of link road from Tandoadam- Berani road to village Yateem Mangsi via Imam Bux Magsi road (Cost Rs.15.988 million).


The Planning & Development Department have observed that the estimated costs of these four schemes are exceeded from the allocated funds earmarked for the MNA. Hence, the costs of these schemes may be reduced, within the budgetary provision.


The above observations of Planning & Development Department have consulted with Mr. Roshandin Junejo MNA, (NA-236) and the scheme at serial No.1 has been deleted and the cost of three remaining schemes have been reduced and the Committee has thoroughly re-examined/scrutinized the modified PC-Is of the following Development Schemes. After detailed discussions, the following decisions were taken.
