- The Complaint Redressal Committee examined and reviewed whole evaluation process considered opinions of both the Complainants.
- 5. The representative of Complaircant No.1 M/s Reliance Consultancy and Engineering Services admitted by himself before the Committee that they do not meet the criteria of 'Specific Experience' of the required value during the last five years. Although he expressed his serious reservation on the condition of five years. The Committee was of the view that they cannot relax the criteria well specified in the EOI document. Accordingly after careful examination the Committee endorsed the earlier decision of Procurement Committee for their disqualification.
- 6. Complainant No.2 M/s ATL-KSB. The reasons for disqualification of this complainant were reviewed by the Complaint Redressal Committee thoroughly. Although it was found that some of the reasons can be overlooked as they cannot be considered material deviation from the EOI requirements but the condition of specific experience is a valid and mandatory requirement. The information provided in the submittal by the Joint Venture Agreement does not meet this criteria, hence the Complaint. Redressal Committee endorsed the earlier decision of Procurement Committee for their disqualification also.

Based on the record presented and examination, the Committee observed that complaints
made by M/s Reliance Consultancy and Engineering Services Pvt Ltd and M/s ATL-KSB merits
no consideration and unanimously recommended that the same may be rejected.
