Under the instructions of the Deputy Director (ENF-I), Sindh Public Procurement Regulatory Authority Government of Sindh Karachi, the corrigendum has been issued for publication in 03 leading News Papers (English/Urdu/Sindhi).

- I. Rule-46(2) of SPP Rules, 2010 stipulates that:
 - a. Each envelope shall contain separately the "FINANCIAL PROPOSAL" & "TECHNICAL PROPOSAL".
 - b. The Envelopes shall stand marked as "FINANCIAL PROPOSAL & TECHNICAL PROPOSAL" as well, so as the confusion may not be raised.
 - c. At the initial stage the envelope marked " TECHNICAL PROPOSAL" will be opened.
 - d. Envelope marked as "FINANCIAL PROPOSAL" shall retained in the custody of procuring agency without opening.
 - e. The procuring agency after evaluating the "TECHNICAL PROPOSAL" in a manner prescribing in advance, without reference to the price can reject any proposal which does not confirm to specify requirements.
 - f. That no amendments in "TECHNICAL PROPOSAL" will be permitted during the technical evaluation.

g. That FINANCIAL PROPOSAL of technically qualified bids shall be opened publically at a time, date & venue and communicated to the bidder in advance.

h. The "FINANCIAL PROPOSAL" of bids found technically non-responsive shall be retained un-opened and shall be returnable to the respective bidders.

i. That bid found to the lowest evaluated or best evaluated shall be accepted.


It is also added that the Date, Time & Venue shall remain same as mentioned in our letter No. DHO/(TENDER 2013-2014)/-16017 DATED 21.08.2013 (Photostat enclosed).
