- c) A minimum requirements for prequalification will be to have successfully completed as prime contractors, the execution of at least one project of a similar nature and complexity comparable to the proposed contract within the last five years.

- d) The applicant must respond to all questions and provide complete information as advised in these documents. Any lapses in providing essential information may result in disqualification of the applicant under relevant provision of SPPRA Rule 2010.
