- > The above quoted price shall be inclusive of all taxes.

Gold plated, Silver Medal, Diameter 1.25" Inches, with University insignia on one face and inscription on the other. Embossed collar border on both sides as per finished and complete in all respects as per Specimen along with ribbon and green velvet box.

- 1. The University reserves the rights to accept or reject any quotation/tender without any reason thereto.
- 2. Sample of Medals as per above specification is to be provided by all the bidders at the time of opening of tender.
- 3. The sample shall be tested at three different laboratories.
- 4. The ribbon should be green color with yellow and maroon stripes.
- 5. Each Medal should be engraved on the reverse side: Year of Convocation Name of the recipient Name of the Medal (as provided in the list) Name of the Examination Name of year of passing Name of Position
- 6. Any defect in content of Medal or Engraving or in Finishing shall be removed by the supplier in accordance with the requirement and keeping the time schedule at all cost.
- 7. The quality of medal will be randomly assessed after finally supply of medals if any change in the quality of gold is found supplier will be held responsible and money will be deducted from the final payment.
- 8. 2% earnest money should be deposited on the total cost of the quoted amount with the tender form in shape of "Pay Order" in the name of University of Karachi.
- 9. The prices to be filled mandatory in the tender documents.
- 10. Only registered suppliers/jewelers with Sales Tax/Income Tax Authorities shall be considered. The prices should be firm and final inclusive of all applicable Govt. Taxes.
- 11. For satisfaction the right to counter check gms/quality of medal from any reputed jeweler is reserved.
- 12. The successful bidders who refuse to supply the materials after accepting purchasing order shall be liable to forfeit their earnest money as a penalty.
- 13. The last date of issuance of tender document is 13-01-2014 up to 4:00 p.m.
- 14. The last date receipt of quotation is 14-01-2014 at 11:30 a.m. The tender shall be opened on the same day at 12 noon in presence of the tenderers who may wish to be present. In case of any holiday or disturbance the tender will be opened on the next working day as per schedule.
