Respected Sir,

This is with reference to tender No. **ED/KIHD/2014/0149** and Tender No. **ED/KIHD/2014/0150** through website of SPPRA for the supply of Angiography and other disposable item and supply of Angioplasty disposable item respectively.

Last date of issuance of tender documents was shown 10-02-2014 and tender opening date is 11-02-2014.for both the tender.

In this regard we would like to inform you that our representative Mr.Parvez Baig visited KIHD on 06-02-2014 and inquired for issuance of tender with Madam Shaista of Social Welfare Dept.

That she informed that the tender will be issued by Accountant Mr.Zahid.

That our representative again visited KIHD on 07-02-2014 & 08-02-2014.But the Accountant Mr.Zahid informed us that tender is not ready for issuance and you should come on next working day.

Subsequently, this is in violation of SPPRA rules act 2009, updated with SINDH PUBLIC PROCUREMENT RULES 2010. Which mentions in clause # 18 under the heading response time SUB Clause # 2 "**Subject to sub rule (1), the response time shall not be less than fifteen calendar days from the date of publications of notice inviting Tender in the newspaper or hoisting in the website, as the case may be.**

However that non issuance of tender at least 15 days after publications is in violation of SPPRA rules clause # 18.however as even two days before the expiry of tender the tender was not issued.

You are requested to kindly investigate this matter and extend the date of tender as per SPPRA rules.

SUBJECT: VIOLATION OF SPPRA RULES.

The undersigned is directed to refer to your complaint received vide e-mail dated 10.02.2014 and to inform that as per Rule-31 of Sindh Public Procurement (SPP) Rules, 2010 (amendment 08.10.2013), any bidder being aggrieved by any act or decision of the procuring agency after the issuance of notice inviting tender may lodge a written complaint to the Complaint Redressal Committee (CRC) of the procuring agency, which shall announce its decision within seven days and intimate the same to the bidder and the Authority within three working days. In case you are not satisfied with the decision of the CRC or CRC fails to arrive at a decision within seven days, you may file an appeal to the Review Committee, provided that that you have not withdrawn the bid security if any deposited by you as per the requirement of Rule 31 & 32.

2. In view of the above, it is advised to file your complaint with the Complaint Redressal Committee of the procuring agency for redressal of your grievance.
