

 A query was raised about the interest on the Mobilization advance as in the event of interest on mobilization advance, it will not be feasible for the contractors to go for it.

Answer: It was informed that PMU has already taken up this issue with the Finance Department, Government of Sindh for waiver of interest on mobilization advance. The Finance Department had shown its inability to "waive off 10% interest on mobilization advance."

2) In BOQ items, details of Earthling are not mentioned

Answer: It was informed that all the specifications are available in the Specification Book. The defails are available in Volume-2, Section-16 (Lightning Protection System).

In BOQ items, MS Pipe connection, no length is provided.

Answer: It was informed that the existing MS/GI Pipes are to be used for connecting with new HDPE pipes through flanges; therefore rates are to be quoted only for connections and cost of material to be used for connection as per drawings.
