### A. GENERAL

## **IB.1** Scope of Bid & Source of Funds **1.1** Scope of Bid

Bidders must quote for the complete scope of work. Any Bid covering partial scope of work will be rejected as non-responsive.

## **1.2 Source of Funds**

c) if prequalification has not undertaken, the Executive Engineer Provincial

(i) company profile;

(ii) works of similar nature and size for each performed in last 3/5 years;

(iii) construction equipments;

(iv) qualification and experience of technical personnel and key site management;
