4. Rates and Prices

- 4.1 Except as otherwise expressly provided under the Conditions Contract, the rates and amounts entered in the Schedule of Prices to be the rates at which the Contractor shall be paid and shall be the inclusive value of the works set forth or implied in the Contract; except for the amounts reimbursable, if any to the Contractor under the Contract.

The Contractor will one receive payment in respect of Provisional Sums if he has been instructed by the Engineer/Procuring Agency to utilise such sums.
