The shifting of books for Five Districts of Karachi and District Thatta will be made from Sindh Textbook Boards Godown Landhi, Karachi, hence, the rates for Jamshoro and Karachi (using Mazda or equivalent) may be offered separately.

The procedure for open competitive bidding as laid down in the Sindh Public Procurement Rule **2010** shall be followed.

The Tenders can be submitted on **20-03-2014** at **11:00 AM** at Head Office, Sindh Textbook Board, Jamshoro and shall be opened on same day at **11:30 AM** in presence of the bidders or their representative to make them available on that day and time in the Committee room of Sindh Textbook Board, Jamshoro.

The bidders shall quote their rates inclusive of Income Tax etc.

The tender can only be submitted on tender form which can be obtained from the office of the undersigned at the Sindh Textbook Board, Jamshoro during office working hours on cash payment of **Rs.500/- (Non-refundable)**.

Each bidder must accompany bid security equal to **5%** of a bid in shape of pay order/demand draft in the name of Sindh Textbook Board, Jamshoro without which tender will not be entertained. Other details and conditions are included in the tender form.

3. The party will be responsible for safe delivery of books at the destination. In case of any loss/damaged is occurred during shifting of books, the party shall be responsible and the Board reserves the right for recovery of loss damage from bill/security.
4. The Tenderer should quote their rates for providing transport as per details given in bidding documents.

5. The payment of the services rendered will be made through cross cheque on submission of bill built along with original receipt of the recipient and satisfactory completion of the job, certified by officer concerned.
6. The Income Tax will be deducted from the bill as per Government rules.
7. The party will provide the transport as and when required by the Board for shifting of Textbooks during the contract period. In case of failure to provide transport within required day, penalty @ of **Rs.10,000/-** per day will be imposed and deducted from the bill of party. In case of complete default, the full amount of security will be forfeited.
8. Any conditional, ambiguous or incomplete offer will not be considered and will be rejected.
9. In case of any dispute arising between parties, the matter shall be referred to the Chairman, Sindh Textbook Board, and decision of the Chairman will be final and binding on the parties and will not be challengeable in any Court of Law.
10. The offers received by the parties will be evaluated on lowest cost basis.
11. The successful bidder will have to execute an agreement with the Board on stamp paper stamped with **03%** of the bid, borne by successful bidders after furnishing security deposit and before carrying out work.
