4. Tenders without Pay Order, similarly conditional tenders shall not be accepted.
5. Pay Order of unsuccessful parties will be returned after 30 days after opening of tenders while pay order of successful party / parties will be refunded after three months of the completion of the supply.
6. Photocopy of General Sales Tax Registration Certificate be enclosed and Income Tax Number should be mentioned clearly. Income Tax shall be deducted from the bill as per Govt. Rules. Copy of Income Tax return / Assessment order of the last three years and bank statement is enclosed with the tender.
7. In case, certain items of a tender are approved and the Tenderer intends to back out of his commitment on any pretext fails to supply the material in the required quantity or specifications, his Bid Security shall be forfeited and he shall be blacklisted for a period of 5 years.
