Scope of Work:

The Project will be executed at Head office of KMC Civic Centre Building, and a part of sites covering different important locations of the area Malir Cantt Gate VI — Parda Park & Islamia College, Lyari Expressway — Abul Hassan Isphahani Road bridge, Disco Bakery — Dhacca Sweets, Chappel Garden - White House Scheme Karachi. The entire area will come under administration of Command and Control Centre plus network operation will provide assistance to Civic Centre Building

Further the Objectives of the proposed project are as detailed are to:

- Improve the security of citizens in the respective areas of Karachi.
 CCTV cameras deployed in congested and crowded areas will add deterrence for the police force.
- To enable work monitoring along with physical security and surveillance.
- Also help other law enforcement agencies to add deterrence in law and order condition
- The video clips can also be provided as an evidence in court of law
- To deploy and effectively use the response force teams.
- To keep crimes under control through continuous monitoring and recording
- Highly sophisticated and reliable surveillance mechanism.

There will be fixed and pan-tilt-zoom type cameras mounted at vantage locations which shall continue monitoring the areas in view of each camera on round the clock basis. The images from these cameras will be displayed in real time at the remote Command & Control Center (CCC), where suitably rated hardware for video management, recording and storage will be provided.

Approx 225 cameras will be mounted on the poles and will be powered from the KESC electric power supply available at the locations of placement of cameras. Furthermore there will be uninterruptible power supply units of adequate standby battery backup for said camera Primary connectivity for video data transmission from the cameras will be through over 100's of kilometers of fiber optic cable, which will be laid from CCC up to network data switches. Suitable number of such switches will be provided at strategic locations to which clusters of cameras will be connected through copper cables (cat 6).

The project will be integrated with the existing system. The bidder will need to assist command and control center team for the integration.
