1. The Tenders are to be sent under Sealed Cover to Excise, Taxation & Narcotics Department, Government of Sindh otherwise Department reserve the right to ignore or reject the bid.
2. Bids shall be in prescribed format sealed, accompanied by earnest money/security deposit of not less than 2 ½ % of the bids price as call deposit from a scheduled bank of Pakistan in favor of Excise, Taxation & Narcotics Department, Government of Sindh.
3. The bids can be submitted in the name of Secretary, Excise, Taxation & Narcotics Department and will be opened on 02-05-2014 at 3:00 p.m. before the Additional Secretary, Excise, Taxation & Narcotics Department / Chairman, Procurement Committee & intending bidders who choose to be present on the occasion.
4. In case of a holiday, the tender will be opened on the next working day.
5. The vendors are required to attach the relevant brochures & explicitly mention in their Quotation.
6. Technical Specifications of their products. Make/model, Brand Country of Origin/Manufacturing Country. (False declaration of Brand's Manufacturing Country.
7. Quotations shall be in accordance with the specification as mentioned in Tender Document..
8. Prices shall be quoted in Pakistani Rupees and shall be inclusive of all applicable taxes and duties & should cover at various locations in Sindh.
9. The suppliers must have at least 5 (five) years of relationship with original Equipment Manufacturer and such as 5 (five) years of experience in handling marketing & maintaining of the quoted Brand.
10. Documentary evidence such as Authorized Distributorship certificate must be enclosed with the quotation.
11. Only firms registered with Income Tax & Sales Tax Department are eligible to participate in the tender. Proof of registration with Income Tax & Sales Tax shall be enclosed with the bid.
12. The Stores shall be supplied, fixed and commissioned at following locations:-
 - a) (1) 100 K.V.A at Motor Registration Wing, Civic Centre, Karachi.
 - b) (4) 50 K.V.A at Motor Registration Authority, Hyderabad, Mirpurkhas, Sukkur & Larkana.
13. All quoted products must carry at least 1 (one) Year comprehensive warranty including free service.

14. The validity period of the bid/offer shall be at least 90 days. The minimum delivery period shall be mentioned in the bid / offer.
15. The Excise, Taxation & Narcotics Department is not bound to accept the lowest or any tender and as such reserve the right to accept or reject any offer or parts thereof without assigning any reason.
16. The Excise, Taxation & Narcotics Department shall reserves the right to increase or decrease quantity of any or all items without assigning any reason.
17. Suppliers engaged in corrupt or fraudulent practices or if have been Blacklisted by any government Department will be declared ineligible.
18. If the supplier is not an Importer / distributor then such a supplier is required to produce a Sales Tax paid invoice issued from the registered importer / distributor concerned from whom he would arrange supply.
19. All taxes applicable under Federal / Provincial / Local Government will be deducted at the time of payment to the contractor.
20. Original tender purchase receipt must be enclosed with the offer.
21. Tender should be sealed with the wax.
22. Representatives of the firms are required to produce Authority Letter at the time of attending in the meeting of opening of Tender bids.
23. Photocopy of Registration Certificate of Directorate of Industries Government of Sindh.
