Bid Security equivalent to 2% of the Total Tender Price (in favor of Accounts Officer, UCG Project Thar) in the shape of Pay Order/Demand Draft must accompany the tender.

3. Interested firms may quote their rate for the following works.

a) Freight forwarded services are required from China Lianyungang Huanghai Machinery Co. Ltd. Lianyungang, Jiangsu, China(for Horizontal Drill Rig), and Shengli Oilfield Shengli Power Machinery Group Co. Dongying Shndong China(for 8XSyngas Genset.) to Port Qasim Karachi, Pakistan with stevedoring services from Vessel to Trucks and container detention 14days margin.

b) Clearing and forwarding services from Port Qasim Karachi.

c) Transportation services from Port Qasim Karachi to UCG Site Tharparkar with loading and unloading services.

4. Description of goods are as follows:

i) One set of Horizontal Directional Drill Rig on deck,
overall Dimensions (14.5m(L)x3.15m(W)x3.4 m (H) Gross weight: 44T).
