#### Method of procurement used

#### Manner and place, date and time for submission of bidding documents

#### Manner and place, date and time of opening of bids

The bids will be opened on the same day i.e.14<sup>th</sup> July at 12 P.M. in the presence of owners or their authorized representatives who intend to be present on the same aforementioned address.

#### Evaluation Criteria

The technical proposal should contain all information as outlined in the terms of reference / specifications whereas the financial proposal should mention the monthly rent inclusive of all government taxes / rates which shall be deducted at the time of making payment. The technical proposals will be evaluated against the laid down specifications and the bungalow on site. The responsive bidders will be notified of the date and time of the opening of financial proposals.

#### Assessment of tender price

The rent will have to be assessed on a monthly basis. The total yearly rent will have to be computed on the basis thereof. It should be inclusive of all government taxes and rates which will be deducted in accordance with the rules at the time of payment.
