- 3. The successful bidder shall provide Animal Health Certificate at the time of delivery confirming that the animals are in good physical condition /sound Health and that they are free from any bacterial, parasitic or protozoal infections.
- 4. The Quarantine Period of animal shall be 15 days commencing from the date of delivery, which shall be entirely at the risk & cost of the supplier. In case of death during quarantine period, no payment will be made to the supplier.
- 5. In case of any death during Quarantine Period, the supplier shall be bound to provide ar other animal in lieu thereof the same sex and age free of charges.
- 6. The supplier shall ensure completion of all legal formalities if so required in case of import, KMC will provide necessary assistance.
- 7. The successful bidder shall bear all expenditure relating to Government Taxes / Duties etc. if any.
- 8. The successful bidder shall be responsible for obtaining CITES Permit, if necessary, in the name of Karachi Metropolitan Corporation and on its behalf.
