Referring to your letter on subject cited above, I want to submit.

- 1- Referring to technical scoring the word Pre-Qualification is not used for the tender process through pre-qualification process but only refers to evaluate bidders (applying through NIT) technically and consider only technically qualified bidders for financial assessment.
- 2- To avoid any confusion regarding the word pre-qualification this word is removed from technical scoring documents.
- 3- The technical scoring criteria document is for bidders of medicines/drugs items. The criteria are made for procuring these items from more sound bidders so that better medicines are procured.
- 4- Regarding criteria 03 of technical scoring documents, these capabilities in personal pertain to principal pharmaceutical whose drugs are quoted for bid.
- 5- Regarding criteria 07 of technical scoring for quality certification, add "give information regarding principal Pharmaceutical".
- 6- A corrigendum regarding these clarifications is posted on the notice board of Sindh Govt. Children Hospital before opening of the bids as per your advice.
