The Tenders will be received by the undersigned on the date viz 29.10.2014 at 1.00 p.m. and opened on same day at 02.00 P.M.


The forms can be collected from this office on any working day till 24.10.2014.

**CONDITIONS**

01. Applicant should not be a Government Employee.
02. Challan of the security deposit of Rs.60,000/- for all the lockups will have to be submitted by the successful contractor / tender before issuance of order. In case he / they fail to submit such challan / Bank Draft within 48 hours of declaration of the result of tenders, their offer will be cancelled and order will be issued in favour of next tender, whose rate is found to be lower than the other tenders (this is only for new contractor).
03. If the challan of earnest money is not found attached with the tender forms, the same shall not be accepted.
04. In default contractors / tender shall be liable to forfeiture of security deposit in part of whole if they fail to abide by the terms and conditions as the case may be and their names will be black listed.
05. The tenders shall not allow any person / persons other than himself / themselves to supply **Cooked Food** except with prior permission of the Commissioner Karachi Division.
06. **No Quotation for Rate of Reduction in Rate will be Entertained after Opening of the Tenders.**

The rates once offered in the tenders and accepted will not be increased and if contractor fails to abide by the terms and conditions of the contract, it will be cancelled at his risk and cost, a part from forfeiture of Security deposit and fresh tenders will also be invited at his risk and cost.

07. In-experienced persons will not be registered without instructions / directions from the Inspector General of Prisons Sindh at Hyderabad.
08. 3.5% Income Tax will be recovered / deducted in case the payment exceeds Rs.50,000/- during the year of the contract.
