- iii. Condition regarding holiday and out of headquarter on opening date be rephrased as; "In case of holiday and unforeseen circumstances on opening date the bids shall be submitted and opened on the next working day. Other terms and condition shall remain same."
- iv. The procuring agency has not furnished bidding documents for hoisting on the website of the Authority as required by Rule-21(4) and 24(2).
- v. The procuring agency has not furnished notification of Procurement Committee in terms of Rule-7 & 8.

It is also advised to furnish annual procurement plan, bidding documents for hoisting on the website of this Authority along with notification of Procurement Committee constituted as per Rule-7, in order to avoid proceeding under Rule-32(A) of SPP Rules, 2010 (amended 2013) which pertains to declaring the procurement as mis-procurement.
