- Clause 1** The firm/ contractor shall enclose the one original and one copy of the documents in a sealed envelope which shall:-
(a) bear the name and address of the Applicant;
(b) be delivered by hand or through courier/ registered mail to address mentioned in advertisement for pre-qualification or in document; and
(c) be clearly marked "Application for Pre-qualification of Contractor for Re-alignment/ Construction of Bund from North Side of Malir River.
- Clause 2** If the envelope is not sealed and marked as required, the procuring agency will assume no responsibility for the misplacement or pre-maturing opening of the document.
- Clause 3** Document shall be prepared in the English language. In case of ICB, the information provided in any other language shall be accompanied by English translation also.
- Clause 4** Firm/ Contractor must respond to all questions and provide complete information as advised in this document. Any lapses to provide essential information may result in dis-qualification of the firm/contractor.
- Clause 5** **Clarification and Modification of Documents (SPP Rule 23)**
Firm/ Contractor, who has obtained documents, may request for clarification of contents of the bidding document in writing, and respond to such queries shall be made in writing within three calendar days, provided they are received at least five calendar days prior to the date of opening of bid.
- Clause 6** **Addendum**
At any time prior to the deadline for submission of documents, the agency may amend the Prequalification Document by issuing addenda. Any addendum issued shall be part of the Prequalification Document and shall be communicated in writing to all who have obtained the prequalification document.

SCOPE OF CONTRACT

1. Required Works

The Contractor is required to construct and complete the works for "Re-alignment / Construction of Bund from North Side of Malir River". The locations involving re-alignment lies within Karachi City, close to Korangi Road.

The works involve channelization of Malir River by constructing internal bunds at specified alignments on right side of Malir River and strengthening of bund on left side along same reach/s.

The two locations for the required re-alignment are:

- At immediate upstream of Jam Sadiq Bridge, for a length of about 1.7km.
- Near Korangi Road Causeway to upstream, for a length of about 3.3km.

2. Items and Quantities of Work

The principle items of works required to be executed include, but are not limited, to the following:

- Jungle Clearance	2.2 million sq.m
- Earthwork for Embankment	1.36 million Cu.m
- Stone Pitching/ Scour Protection works	0.15 million Cu.m
- Stone Dumping	0.33 million Cu.m
- Sand Grouting	0.23 million sq.m

Care and handling of water will be required during construction.
