

67. It is submitted that the Tender for Tablets, Syrup etc. were opened on 17th November, 2014 and the bid validity thereof is going to expire on 15th February, 2015. The bidding process delayed due to hectic busy official commitments of members of Procurement Committee within outside of province and more over the members were also busy in finalizing the bidding documents for the procurement Contraceptive through international competitive bidding which is new innovation. The purchase committee meeting which was to be held in first week of February, 2015 could not be held due to one week and more leave of chairman of Purchase Committee as well as Technical Committee. Further the Technical members of Purchase Committee namely Additional Secretary (Medical) was also on leave hence the bidding process delayed and evaluation could not be culminated in terms Rule 45 of SPPRA.

68. As per SPPRA Rule 2010 (Amended 2013) read with Rule 38(2) the extension of bid validity may be allowed subject to approval by the Competent Authority by the procuring agency and with reason to be recorded in writing. Further Rule 38(3) says after obtaining such approval the procuring agency shall request in writing all bidders to extend the bid validity period. Such a request shall be made before the date of expiry of original bid validity period. Rule 38 (4) says such a extension shall not be for more than original period of bid validity.

69. Given the above reasons and SPPRA Rules, it is proposed that competent authority may approve extension of bid validity as per rule 38(2) for a period of 30 days and the bidders may be requested in writing for extension of bid validity in terms of Rule 38(3) in respect of Tablets, Syrup etc opened on 17th November, 2014.
