
SUBJECT: LOI NO:TC/G-55/65/ DATED 25.02.2015

PQR Ref No: TC/G-55/1203 dated 12.12.2014

I am directed to refer your letter No:TC/G-55/567/2015 dated 18.05.2015 and to state that clarification(s) furnished by you is not plausible hence observation(s) already conveyed vide SPPRA letter dated 12.05.2015 (copy enclosed) is again endorsed as below:

- i. Prequalification notice was not published in Urdu newspaper, which is violation of Rule-17(2) of SPP Rules, 2010 (Amended-2013).
- ii. The scope, estimated cost and project period was not mentioned in the Prequalification Notice, which is mandatory requirement in terms of Clause-2.16(a) of Guidelines / Regulations for Procurement of Works. Clarification/ justification is required.
- iii. Procuring Agency set eligibility criteria, whereby contractors are required to have valid registration of C-3 PEC certificate for all works/schemes mentioned in the procurement plan, whereas, according to PEC guidelines for works No:1 & 3 require Category and for work No:6 required C-4 category.
- iv. Pre-qualification process carried for various works which is not in consonance with Rule-27(2) of SPP Rules, 2010 (Amended-2013) & Clause-2.15 of Guidelines / Regulations for Procurement of Works, which stipulates that:
Proviso of Rule-27(2) "Provided that pre-qualification may be carried out only for specific procurement contract and shall be applicable only to that particular assignment"
Clause-2.15 "Pre-qualification is made on tender to tender basis and is valid for such project / scheme only".

2. In view of the above said violation(s), Rule-25 & 26 of SPP Rules, 2010 (Amended-2013) is advisable. However, it is informed that subject procurement has been placed before Sub-Committee of SPPRA Board constituted for reviewing the cases of non-compliance of SPP Rules, 2010 (Amended-2013) and mis-procurement under Rule-32(A) of SPP Rules, 2010 (Amended-2013).
