INVITATION TO BID

Sindh Service Tribunal, Karachi (hereinafter referred to as Procuring Agency) invites sealed bids from eligible bidders for supply of Generator as mentioned at annexure A.

- 1. The Bid shall comprise one single envelope containing the financial proposal and required information montioned at Annexure A.
- 2. Interested eligible bidders may obtain further information on the bid from the office of Registrar, Sindh Service Tribunal, Barrack No.21, Sindh Secretariat 4-A, Karachi.
- A complete set of bidding documents may be purchased by any interested eligible bidder from the office of Registrar, Sindh Service Tribunal, Barrack No.21, Sindh Secretariat 4-A, Karachi. Upon payment of a non-refundable fee of Rs.500/- from the date of hoisting up to 29.1.2015 during normal working hours (8 00 am to 3.00 pm) and can also be downloaded from PPRA website.
- 4. All bids must be accompanied by a bid security equivalent to 2.5% of total bid amount in the shape of pay order or demand draft, and must be delivered to the office of Registrar, Sindh Service Tribunal, Barrack No.21, Sindh Secretariat 4-A, Karachi from the date of hoisting to 29.1.2015. The bids will be publicly opened in the office of Registrar, Sindh Service Tribunal, Barrack No.21, Sindh Secretariat 4-A, Karachi at 2.00pm on the same day in presence of bidders who wish to remain present.
- 5. (i) The bid shall comprise a single package. The envelopes shall be marked as "BID FOR SUPPLY OF GENERATOR" in bold and legible letters to avoid the confusion.

(ii) The procuring agency shall evaluate the proposal in a manner prescribed in advance, and reject any proposal which do not conform to the specified requirements.

(iii) During the evaluation no amendments in the proposal shall be permitted.

- 6. The Sindh Service Tribunal, Karachi will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
- 7. Bidders shall submit Bids, which comply with the Bidding Documents. Alternative Bids will not be considered. The attentions of bidders is drawn to the provisions of Clause on "Determination of Responsiveness of Bid" regarding the rejection of Bids, which are not substantially responsive to the recuirements of the Bidding Documents.
- 8. The Procuring Agency reserves the right to reject all or any bid subject to relevant provisions of SPPRa Rules, 2010.
- 9. All prices quoted must include any Taxes applicable, such as GST, Income Tax etc. If not specifically mentioned in the Quotation, then it will be presumed that the prices include all the taxes.
- 10. In case of failure to complete the Task within the stipulated time period performance security amount will be forfeited and the company will not be allowed to participate in future tenders as well.

EVALUATION AND COMPARISON OF TECHNICAL AND FINANCIAL BIDS

- > Procuring Agency reserves the right to reject any or all proposals subject to SPPRA rules.
- > Authority Letter is required from Principal Company for product and vendor authentication.
- > The tender must be filled on prescribed form without any alteration/over writing.
- Conditional tenders/bids will not be acceptable.
- Procuring Agency reserves the right to increase or decrease the scope of work / number of items subject to SPPRA rules.

(i) Bid Security

A bid security in the shape of a Bank Draft/Pay Order in favour of Registrar, Sindh Service Tribunal, Karachi equivalent to 2.5% of the total cost of bid should be submitted along with the tender. Bid security of unsuccessful bidder will be released as soon contract is awarded to successful bidder.

(ii) **Performance Security**

A performance security in shape of Bank Draft / Pay Order in favour of Registrar, Sindh Service Tribunal, Karachi equivalent to 06% of the total value of contract will be required to be submitted by successful bidder before placement of final contract.

(iii) Validity of the proposal

All proposal and price shall remain valid for a period of 90 days from the closing date of the submission of the proposal.

(iv) Currency

All currency in the proposal shall be quoted in Pakistan Rupees (PKR)

(v) Withholding Tax, Sales Tax and other Taxes

(viii) Compliance to Specifications

The Bidder to provide information as per (Annexure-A).Bidder should not propose any kind of refurbished equipment/components in their technical proposals.

(ix) Financial Capabilities

The Bidder shall describe the financial position of is organization. Income Statement or Annual Report should be included in the detailed Technical proposal.
