the procuring agency regarding disqualification may seek relief through the mechanism of grievance redressal, as provided under Rule 31.

REDRESSAL OF GRIEVANCES AND SETTLEMENT OF DISPUTES

31. Mechanism for Redressal of Grievances

- (1) The procuring agency shall constitute a committee for complaint redressal comprising odd number of persons, with appropriate powers and authorizations, to address the complaints of bidders that may occur during the procurement proceedings.
- (2) The committee shall be headed by head of the procuring agency or an official of the procuring agency, at least one rank senior to the head of the procurement committee and shall include the following;
 - (a) District Accounts Officer, or his representative, in case of the local governments or provincial line departments at district level, or a representative of the Accountant General, Sindh in case of Government departments at the provincial level;
 - (b) an independent professional from the relevant field concerning the procurement process in question, to be nominated by the head of procuring agency;
- (3) [Any bidder being aggrieved by any act or decision of the procuring agency after the issuance of notice inviting tender may lodge a written complaint;]²¹
- (4) The complaint redressal committee upon receiving a complaint from an aggrieved bidder may, if satisfied;
 - (a) prohibit the procurement committee from acting or deciding in a manner, inconsistent with these rules and regulations;
 - (b) annul in whole or in part, any unauthorized act or decision of the procurement committee; and

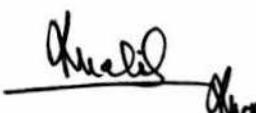

**MINUTES OF COMPLAINT REDRESSAL COMMITTEE MEETING AGAINST

The meeting of Complaint Redressal Committee (approval of committee attached) for reviewing the complaint of M/s Illahi Bux against the Tender No. CED/26/050515 of Construction of roads along with electric poles and storm water drainage works for Infrastructure Development of the new campus of the premier S & T institutions-The ICCBS, was held on 30th June, 2015 in the meeting room of H.E.J. building.

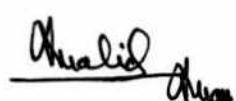

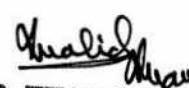
Civil Engineer Sadia introduced the members of the Committee with the Convener. The meeting started and discussed the following points:

- Engr. Sadia presented the report and explained that tender was floated on 15th April, 2015 and opened on 5th May, 2015.
- She explained that this was single stage single envelope tender. In this tender Bidder had to submit the financial bid along with required mandatory documents, which were mentioned in the advertisement as well as in the tender documents (Copy of advertisement attached at Annexure: A and mandatory requirements of tender documents attached at Annexure: E-E1).
- She further informed that 8 bidders participated in the tender, however four were rejected and four bids were accepted.
- Mr. Khadim Hussain asked about the reason of rejection of four bids.
- Engr. Sadia explained that one bidder did not provide the earnest money in the shape of pay order whilst other bidders did not provide the mandatory details which are listed in the advertisement and also in the bidding documents.
- She further informed that bid of M/s Illahi Bux Ansari (complainant) was rejected due to incomplete BOQ for unscheduled items (a necessary requirement as it may lead to unavailability of item rates for non-scheduled items) as well as not providing the mandatory requirements.
- Mr. Tahir Faridi informed that the tender opening sheet is attached at Annexure: B-B1, which shows the reasons of rejection with the bidder signatures.
- She explained that after the opening of bid, rejected bidder launched a complain regarding the rejection of his bid.
- Committee asked about the plea of M/s Illahi Bux Ansari, which he submitted to SPPRA.
- Engr. Sadia explained that letter of M/s Illahi Bux Ansari is attached at Annexure: D, in which he pointed out the cost difference between the lowest evaluated bidder and his bid.
- Convener asked Engr. Sadia to explain in detail about the short coming in the bid of M/s Illahi Bux Ansari, due to which his bid was rejected.

- Engr. Sadia informed that when the bid opened, it was noticed the BOQ pages attached at Annexure: C (3E-4 to 3E-5) are not filled by the bidder although he quoted lump sum amount against these items in the summary page, which is attached at Annexure: C. Therefore, it will be very difficult to match the bid apple to apple. Further on, if quantity of any of the non-scheduled item is increased or decreased during the execution then there will be no way to pay these items as the item rates were not defined. Therefore, his bid was rejected due to the incomplete BOQ.
- Mr. Tahir Faridi also informed that besides the fact of incomplete BOQ, he did not provide the mandatory requirements like PEC valid certificates and audited balance sheets for last five years through which average annual turnover and working capital may be determined.
- Convener asked Engr. Sadia to show M/s Illahi Bux Ansari documents.
- Engr. Sadia informed that these documents are attached at Annexure :F. The attached PEC certificate is valid till 31st December, 2014. Further on, she also showed the bank statement of random years through which no body may know about the annual turnover and working capital.
- Mr. Khadim Hussain Meerani told that the reason of rejection of M/s illahi Bux, mentioned in the opening sheet is incomplete BOQ. He further told that absence of mandatory requirements should also have been mentioned along with incomplete BOQ.
- Mr. Haris Qureshi informed that M/s Illahi Bux Ansari submitted his bid along with the profile. At the time of bid opening it was very difficult to check the mandatory requirements in the entire profile. When bidder launched a complaint, his bid was reviewed completely and it was found out that he also did not provide the essential requirements.
- Convener asked that M/s illahi Bux Ansari did not fulfill the criteria mentioned in the advertisement and tender documents, then why we are claiming him as a bidder.
- Mr. Haseeb Ansari informed that M/s Illahi Bux Ansari is a non-responsive bidder as he did not respond to our requirements which are essential for eligibility.

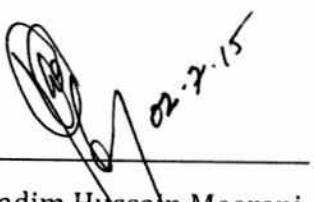
- Convener asked from Mr. Khadim Hussain Meerani and Mr. Haseeb Ansari about the decision regarding his complaint.
- Mr. Khadim Hussain and Mr. Haseeb both replied that his complain may be rejected as he did not fulfill the eligibility criteria and also produced incomplete BOQ. Thus, the decision of rejection of bid stands and his plea may be discarded.
- Convener advised Engr. Sadia and Mr. Tahir Faridi to make sure that all of the documents of lowest evaluated bidder should be checked properly before awarding the work.
- Meeting adjourned with vote of thanks.
