

SUBJECT:- CANCELLATION / RE-INVITATION FOR THE WORK "PROVIDING AND LAYING PVC INSULATED WITH 4-CORE 120 MM CABLE FOR GENERATOR ROOM, BACK SIDE AT FILTER PLANT, GHARO"

The RE has submitted that the above subjected case was prepared in the financial year 2014-15 and tenders were opened on 19.5.2015. Out of 02 bidders, M/s. G.M. Enterprises, quoted Rs.20,38,520/= and declared the first lowest by the Tender Procurement Committee-I of KW&SB, but the work has not been executed due to shortage of time as explained by the concerned Resident Engineer, in para-74-78/N.

Now the case is submitted with strong recommendation for obtaining technically sanction and administrative/financial approval of Managing Director, KW&SB for cancellation of previous tender opened on 19.5.2015 and Re-Invitation of tenders through press publication in daily leading newspaper viz. (Urdu, English & Sindhi) under SPPRA-2010 as well as website of Govt. of Sindh for the above subjected work for Rs.20,38,770/= duly checked / assessed by CE(IPD) and Director Design Office, expenditure will be charged from B.G. No.6433-41 by the way of Re-appropriation of B.G.No.6433-42 for the year 2015-16, (B-20 attached), as requested by R.E. vide para-74-78/N with permission to reimbursement of payment for Rs.2,000/= (Through Pay Order) of upload/hosting to the website of SPPRA authority and same will be reimbursed in favour of R.E., Gharo (P&F) Division, duly recommended by SE and DCE vide para-80-81/N and 82/N, please.
