#### **TERMS & CONDITIONS**

Offers shall remain valid for 90 days from the date of opening. The bidders shall quote their prices inclusive of all applicable duties / Taxes and transportation etc. and all other expenses on free delivery to Consignee's end. Price should be quoted in Figures & Words both, failing which the offer will be ignored.

## 1.0 GENERAL CONDITIONS & INSTRUCTIONS:

- 1.1 In this tender, method of procurement shall be "SINGLE STAGE ONE ENVELOPE" procedure as per SPPRA rules 2010. Amended rules 2013.
- 1.2 Bid shall comprise a single package The envelope shall contain financial proposal and the technical proposal. The envelope must contain tender inquiry No. on the top, the name of the Bidder should be affixed on the face of the envelope on the left side. The envelope should be sealed and addressed to Commissioner SESSI Karachi and inserted in Tender box on the scheduled date and time.

## 1.3 Proposal should have the following documents:

- I. Original Tender receipt (10 points)
- II. NTN Certificate. ( 10 points )
- III. Sales Tax Registration Certificate. (10 points)
- IV. Last three years tax returns of Bidder. (10 points)
- V Original Pay Order! Bank Draft of Earnest money. (20 points)
- VI Original copy of the Bid offer with Quoted price. (10 Points)
- VII Last three year experience of supply of food item to any institution ( proof must be provided 30 points )

Note Bidder must score 80% to qualify technical criteria

- 1.7 The tender must be free from erasing, cutting and over writing. In case of erasing, cutting and over writing, authorized person should initial it, duly stamped.
- 1.8 Rates of each item should be written in **figures as well as in words**. Arithmetical errors will be rectified on this basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and the quantity, the unit price shall prevail and the total price shall be corrected. In case of discrepancy the price in words will be authenticated and final.
- 1.9 No Tender will be entertained without Bid Security. Conditional tender will not be accepted.
- 1.10 Tenders shall be accompanied by Bid Security © 2.5 % of the value of tender quoted by them in form of Pay Order / Demand Draft in favor of Commissioner SESSI, Karachi which

shall remain valid for 28 days beyond the Bid validity period.

- 1.11 The Bid Security shall be released to the unsuccessful bidders once the contract has been signed with the successful bidders or the validity period has expired.
- 1.12 The Bid Security shall be released to successful bidders after submission of performance security.
- 1.13 The tendered rate should be inclusive of all applicable taxes to Federal & Provincial Govt. or local bodies and will be deducted from the bill of the contractors / suppliers.
- 1.14 One "SAMPLE TENDER PROFORMA" is supplied with the lists of items to be purchased. The items have to be quoted on the Performa; duly filled stamped & signed by the authorized bidder. Only those items shall, be typed on the Performa / separate Letter head (as per serial of Performa) for which the rates are to be quoted. Any alteration/ correction must be initialed and each page is to be signed and stamped at the bottom.
- 1.15 The supplies should be in commercial pack and delivered at the designated place by the authorized representative of the firm at the risk and cost of the supplier. Any breakage or shortage of stock will be recovered from the supplier.
- 1.16 Meat will be weighed at the hospital after it has been cut into small pieces.
- 1.17 Fresh items like Fruits, Vegetables, bread etc should be supplied on daily basis.
- 2. SPECIAL CONDITIONS:

- 2.1 The quoted rates once offered by the firms will not be changed during the contract period.
- 2.2 The bidders shall quote their price both in figure and in words on Free delivery basis to SESSI Hospitals .
- 2.5 if a bidder supply sub-standard, misbranded or contaminated item(s) etc., those will be destroyed and payment will not be made to the supplier. The supplier will be responsible to provide the fresh stock of standard quality against the rejected items. Otherwise amount equivalent to the supplied quantity of defective goods will be deducted from their bill and supplier may be black listed by the competent authority accordance with the offence and hence their performance security will be forfeited.
- 2.4 The Technical evaluation depends upon the documents provided by the bidder mentioned in clause 1.3 of Terms and Conditions of the tender.
- 2.5 2.13 If any of the firm/supplier will not supply the Goods after getting award of contract, the whole performance security shall be forfeited and the same will be black listed.

### 3. PURCHASER'S RIGHT TO VARY QUANTITIES

The authority reserves right to increase / decrease or delete the quantities of goods at the time of award of contract and also reserves the right to enhance the quantity of goods originally specified in the schedule of requirement without any change in unit price or other terms and conditions of goods at any time during contract period.

## 4. PURCHASER'S RIGHT TO ACCEPT ANY BID AND REJECT ANY OR ALL BIDS:

The Competent authority reserves the right to purchase full or part of the store or ignore / scrap / cancel the tender as per relevant rules of SPPRA-2010. Amended rules 2013

#### 5. PERFORMANCE SECURITY:

The successful bidders will have to deposit the requisite security in the shape of a Pay Order / Demand Draft at 5% value of the order amount. The same will be released after successful completion of stores.
