Terms & Conditions

1. Publisher will have to provide call deposit at the cost of Rs. 20,000/- or 3% of bid amount which ever is higher in the favor of Peoples University of Medical & Health Sciences for Women Shaheed Benazir Abad, in case of failure the tender document will not be entertained (Total Amount of call deposit will be re-fixed at 3% at the time of issue supply order)
2. Income tax, G.S.T & other applicable taxes and duties at the government prescribed rates are deductible from the bill.
3. Before supply of the prospectus (in case of supply order is issued) samples will have to be approved by the Admission Department.
4. Quantity at any time can be increased / decreased or can deleted at any time.
5. The publisher will have to produce evidence in respect of their registration with income tax and sales tax department.
